

Ohio Short Term Certificate Grant Application for Non-Credit Programs through Workforce & Community Services OFFICE OF FINANCIAL AID

About This Form

The Ohio Short-Term Certificate Grant is for Ohio residents enrolled in certain short-term certificate programs.

Eligibility requirements

To be eligible for the scholarship, you must meet the following criteria:

- Submit an Ohio Short-Term Certificate Grant application and be selected as a recipient.
- Be an Ohio resident.
- Be registered for **Selective Service** if required to register by law. Please visit https://www.owens.edu/media/financial_aid/banner-links/SELECT.pdf for details.
- Be enrolled in one of the **eligible programs** listed on this application.
- Complete one of the following:
 - Complete the Free Application for Federal Student Aid (FAFSA®). The U.S. Department of Education will use your FAFSA® to calculate your Expected Family Contribution (EFC). Please note that Non-Credit programs are not eligible for most other financial aid programs.
 - For Summer 2023, Fall 2023, or Spring 2024, complete the 2023-2024 FAFSA®. The resulting EFC must be 6656 or lower.
 - o Provide documentation that one of the following criteria are met.
 - You are eligible for WIO (Workforce Innovation and Opportunity Act) benefits.
 - You have lost your job (not including quitting a job voluntarily).
 - You have been laid off or received a lay-off notice from your job.
 - You are self-employed but are unemployed due to general low economic conditions or a natural disaster.
 - You are the spouse of an active duty member of the Armed Forces and have experienced a loss of employment because of relocating due to permanent change in duty station; or are unemployed or underemployed, and experiencing difficulty in obtaining or upgrading employment.
 - You are a displaced homemaker (a person who previously provided unpaid services to the family, are no longer supported by your spouse, are unemployed or underemployed, and are having trouble finding or upgrading employment).
- Complete courses successfully to continue eligibility.

Awards

- Awards may be used in summer, fall, or spring semesters.
- Up to \$2,000 can be awarded per certificate program.
- Awards can only be used for instructional fees, general fees, and other approved fees (such as lab and course material fees).
- You may receive a **maximum of three awards** totaling \$2,000 each for different short-term certificates. Additional awards are based on successfully completing one short-term certificate before receiving another award.
- Funding is limited and only available through Spring 2024.
